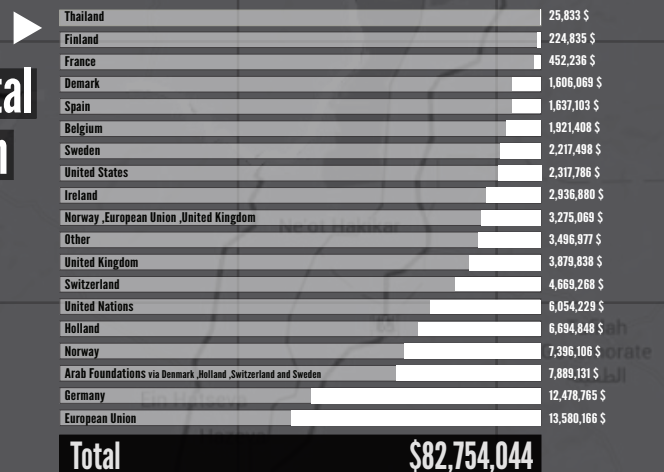

# Foreword

## The international Boycott Divestment

and Sanctions (BDS) movement has one goal: to convince the world that the State of Israel has no right to exist. The hope of this hateful movement is that Israel will crumble from within as a result of international isolation, as what occurred in South Africa during its apartheid regime.

The goal of anti-Israel NGOs operating in Israel by means of funding from foreign governments and the New Israel Fund (NIF) is different. Their goal is to inject doubt in the heart of Israeli society

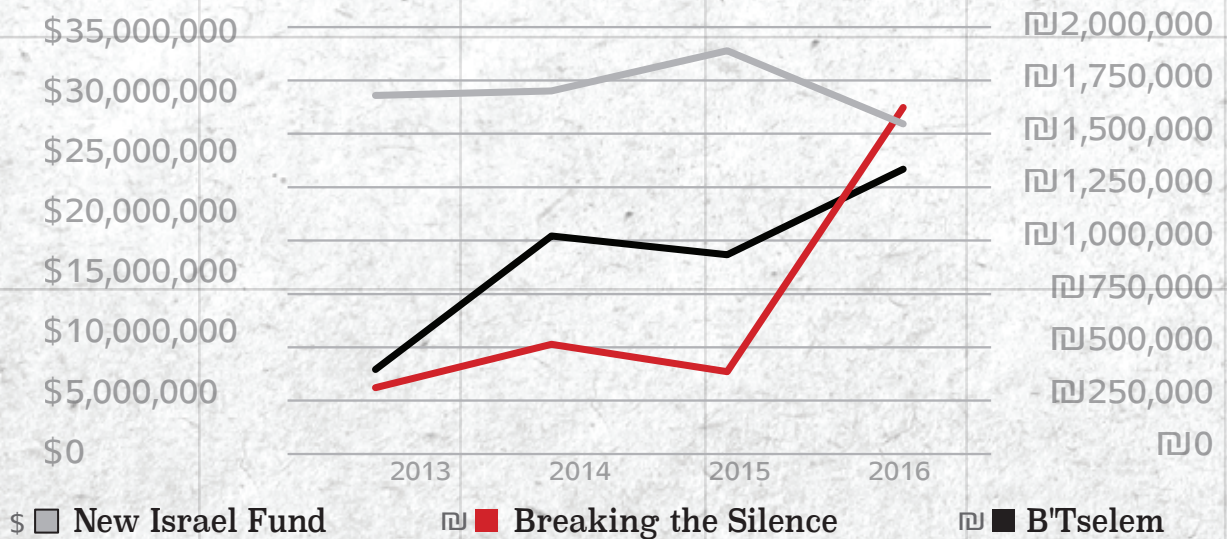
in order to undermine it from within. Their modus operandi is to dissect Israel into different regions and delegitimize each and every one of them. Thus, in the Negev there are organizations accusing Israel of ethnic cleansing the Bedouin community; in Gaza, organizations accusing Israel of perpetrating war crimes; in Judea, Samaria and the Jordan Valley, organizations accusing Israel of land theft an apartheid; in south Tel-Aviv, organizations accusing Israel of racism against illegal migrant workers; in the Galilee, organizations promoting isolationism among Israeli-Arab citizens; and in the Golan,

organizations accusing Israel of illegal occupation. If this was not enough, many of these anti-Israel organizations operate in the Israeli judicial system, with a focus on the Supreme Court, where they submit a flood of legal petitions against Israel's domestic policies and in defense of terrorists and their families. This map provides a birds-eye view of the assault against Israel from within – an assault that is perpetrated by Israeli organizations, which for all intents and purposes act as foreign agents at the behest of European governments and of the foreign political entity, the New Israel Fund.

# Funding



Despite a plummet in overall donations to the the New Israel Fund, they have greatly increased their funding the radical NGOs "Breaking the Silence" and "B'Tselem."



The New Israel Fund is a foreign political entity headquartered in the United States. It is not registered as an official non-profit organization in Israel



The majority of the New Israel Fund's Executive Board members live outside of Israel.

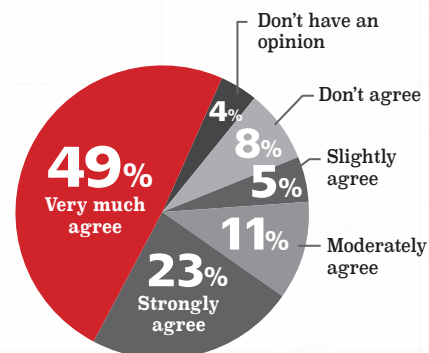

September 2016 poll – Panel Project Midgam

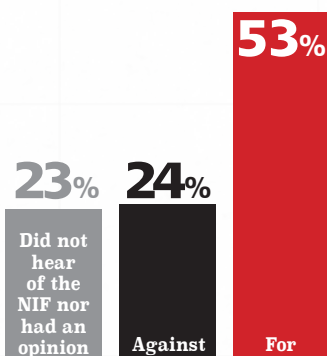
In your opinion, are the activities of left-wing organizations in Israel like "Breaking Silence," "B'Tselem," and others legitimate?

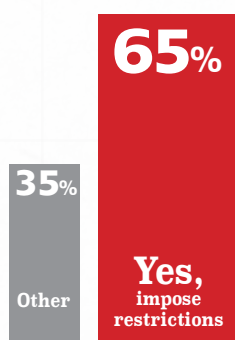

Are you for or against a law that would prohibit the New Fund of Israel from operating in Israel?



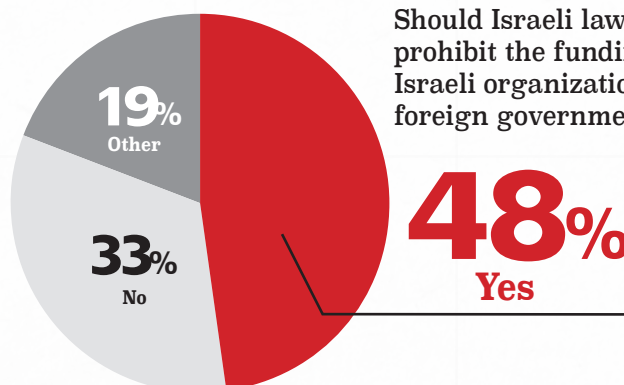
December 2015 Poll – Smith Institute

- ▶ **End public funding** of all foreign agent organizations
- ▶ **Prohibit "Machsom Watch"** and other organizations from collecting and publishing information on the IDF's operational activities
- ▶ **Halt by means of legislation and taxation** the funding of Israeli organizations by foreign governments
- ▶ **Increase Israel's influence** in Europe and the US to outlaw BDS activity
